## CIUS for EN 16931-1:2017

### Introduction

This document describe the CORE INVOICE USAGE SPECIFICATION for the EN16931-1:2017 invoices sent to the Public Administrations through de single point of contact FACe. This specification is available to be used by other spanish entry points.

Syntaxes supported by EN 16931-1 standard, and therefore to those applied by this CIUS, are the following ones:

- 1. UBL invoice and credit note messages as defined in ISO/IEC 19845:2015
- 2. UN/CEFACT Cross Industry Invoice XML message as specified in XML Schemas 16B (SCRDM CII) 83

The present definition of the CIUS-ES-FACE applies to Spanish and foreing suppliers who submit invoices in compliance with EN16931-1:2017.

Electronic invoices sent to Spanish Public Administrations have to include identification codes for the target units.

These codes have to indentify compulsorily the following three units: accounting office, managing office and executing office. Optionally other units codes with different roles are able to be included.

The encoding to be used for the indentification of these three units has to be DIR3 encoding. DIR3 codes can be consulted directly to the contracting unit or in the web <a href="https://face.gob.es">https://face.gob.es</a>

The ROLES allowed to identify DIR3 units are the following ones:

The accounting office has to be encoded with **ID 01**. The managing office has to be encoded with **ID 02**. The executing office has to be encoded with **ID 03**.

The DIR3 codes of these three units have to be included in this field (BT-10) mandatorily. Other units with others ID-ROLE (not 01, 02 y 03) can be included optionally.

Unit format in BT-10: "ID|CODE|".
